**Cancellation Policy**

1. A \$300 deposit (per course and person) is required to secure your booking. Cancellation of a course must be made at least 14 working days prior to the course date or the \$300 deposit will be forfeited.
2. As a general rule refunds will not be provided for "no-shows". However, at the sole discretion of CSL refunds may be allowed on a pro-rata basis, depending on the circumstances and costs to CSL associated with the non-attendance.
3. Substitutions of students from the same company are accepted only for the whole course as long as notice is given 1 working day in advance.
4. CSL and its instructors reserve the right to cancel any courses or event which the Training Manager deems impractical or inadvisable to deliver due to insufficient numbers, illness, travel disruptions, internet disruptions, unforeseen circumstances or other events commonly classed as *force majeure*.
